No visitors will be allowed on site unless unavoidable / supporting specific needs / education of children or staff / supporting school improvement / other TRUST employees / out of school hours visits. Music teachers, delivering to individuals and small groups from one bubble only, may currently use the village hall meeting room for lessons. According to the village hall specific RA, full antibacterial cleaning must be carried out before and after every lesson. Track & trace forms must to be completed by all visitors; hand sanitiser must be used on arrival and face coverings must be worn when social distancing is not possible, also in and around communal areas and in bubble	Yes	Severity:4 Likelihood:1 Risk Rating:4
